The editors have included fairly extensive selections from some of the major materials that have surrounded subsequent war crime litigation. Also included are an epilogue by Michael Ignatieff; an eleven-entry appendix; a glossary containing over 200 words; a reference section of over 1,400 citations from a wide variety of legal, historical and international relations literature; and a name and subject index.
